Last Health, Education and Neighborhood Councils Committee (HENC) meeting made recommendations related to 2018 elections pushed to 2019 with option for Neighborhood Councils (NC) who want elections may have a selection process by submitting a stipulation worksheet by November 1, 2017. Until City council adopts recommendations, Department is still waiting to proceed on the other instructions given.

Commissioner Shaffer asked for clarification on Civic Engagement. GM Liu provided clarification of Civic U. Department received funding to hire a FUZE Fellow to focus on research to create the Office of Civic Engagement.

Commissioner Wehbe asked about process for NC to have a Selection in 2018. GM Liu provided process. Commissioner Wehbe asked when information will be sent to NCs. GM Liu stated info sent out in weekly newsletter.

GM Liu additionally Department is doing a demographics survey gathering info related to gender, ethnicity and age range.

Commissioner Shaffer asked for clarification how "linked back" to board member's name. GM Liu provided clarification.

Biggest changes are to process where Commission receives approved application and proposed bylaws prior to vote which would offer more transparency and address concerns of stakeholders voting in regards to boundaries and bylaws. Modifications to subdivision policy would also address subdivision applications that do not conform to policy upfront.

- Request City Attorney to prepare and present the appropriate ordinances to change Neighborhood Councils elections conducted by City Clerk to odd number years beginning in 2019 and include any necessary language for a one time extension of terms from 2018-2019
- 2. Instruct the Department of Neighborhood Empowerment to
 - a. Provide a stipulation sheet to all Neighborhood Councils with an option to hold the selections in 2018 if the Neighborhood Council chooses to do so
 - b. convene a working group of interested NC members to provide recommendations for the 2019 elections including discussion of online voting efficacy, online voting security, online voting documentation, effective candidate recruitment outreach methods and tools, tailoring outreach to specific neighborhoods, timing of elections, outreach funding, voting age, ballot type, stakeholder status definition and other topics deemed to be crucial to running an effective 2019 election
- 3. Request the Neighborhood Councils to amend their bylaws, if necessary, to effectuate the change of Neighborhood Council Elections from 2018 to 2019.
- 4. Instruct the City Administrative Officer (CAO) to report on the funding necessary to enable EmpowerLA to begin the Neighborhood Council Election outreach process in September 2017.
- 5. Instruct the City Clerk and EmpowerLA, in consultation with the City Attorney, to develop guidelines for the processing and security of Neighborhood Council voter registration information.
- Instruct the City Clerk and EmpowerLA to review and modify the online voter registration and voting system for future online Neighborhood Council Elections.
- Authorize the City Clerk to use up to \$250,000 in funds appropriated for Fiscal Year (FY) 2017-18 Neighborhood Council Elections for the online build out/set up of the remaining 46 Neighborhood Councils and any online voting related hardware/software if online elections are to be offered in FY 2018-19.
- 8. Instruct the City Clerk to work with the CAO on transferring/reverting the remaining balance to the proper location.
- Authorize the Department of Neighborhood Empowerment (DONE) to use finds appropriated for FY 2017-18 Neighborhood Council election funds for election outreach this FY in preparation for Neighborhood Council elections in FY 2018-19.

Commissioner Atkinson recommended public comment be held back to next commission meeting.

Commissioner Lipmen recommended drafting a letter to City Council supporting the HENC recommendation and address any concern Commission may have.

California Code of Civil Procedure Section 1094.6 governs the time in which a party may seek judicial review of this determination. Under that provision, a petitioner may seek judicial review of any decision of the City pursuant to California Code of Civil Procedure Section 1094.5 only if the petition for Writ of Mandate pursuant to that section is filed no later than the 90th day following the date on which the City's decision became final.

RECONSIDERATION:

The Commission may make a MOTION TO RECONSIDER and alter its action taken on any item listed on this agenda at any time during this meeting, or make a MOTION TO RECONSIDER at its next regular meeting as indicated below:

If the Commission moves and approves a Motion for Reconsideration at the *initial* meeting wherein an action was taken, then the underlying item may be reconsidered at that time.

If the Commission moves and approves a Motion for Reconsideration at the next regular meeting then consideration of the item may only occur at this regularly scheduled meeting if the item for consideration has been placed on that meeting's agenda.
