Under that provision, a petitioner may seek judicial review of any decision of the City pursuant to California Code of Civil Procedure Section 1094.5 only if the petition for Writ of Mandate pursuant to that section is filed no later than the 90th day following the date on which the City's decision became final.

RECONSIDERATION:

The Commission may make a MOTION TO RECONSIDER and alter its action taken on any item listed on this agenda at any time during this meeting, or make a MOTION TO RECONSIDER at its next regular meeting as indicated below:

Comments on the subdivision amendments

submitted by Judith Daniels VANC executive board member Chatsworth Neighborhood Council Land Use Committee, current member Chatsworth Neighborhood Council, former president also a former long-time editor at the Los Angeles Times

My comments are all marked with arrows (---->).

- a) The subdivision petition shall identify five stakeholders who are authorized to receive notice and make decisions regarding the subdivision petition, including any bylaw changes.
 - ----> This says the 5 stakeholders are authorized to make decisions, but it doesn't require them to be stakeholders within the proposed NC boundaries.

Notice shall be to all current board members of the affected certified Neighborhood Councils in file with the Department,

----> ... board members ... on file ...

All such notices shall be accomplished as soon as practicable.

----> This wording is so broad and undefined that it is useless without some limits or parameters. Allowing for reasonable time to accomplish tasks is important. But this wording doesn't actually set any limits and there is no penalty for not abiding by the intention to give timely information.

b) Outreach.

The Department shall be responsible for outreach to both the proposed subdivision and any effected certified Neighborhood Councils. To the extent possible the Department shall hold informational town hall meetings in both the proposed subdivision area and within the boundaries of any effected certified Neighborhood Councils excluding the proposed subdivision area.

- ----> The affected certified NCs.
- ----> This should specify what the purpose of the outreach is. If it is to notify and/or educate stakeholders that there is a request for a new NC and/or that there will be an election in their community for a new NC, or outreach for any other specific purposes, it should be stated in this paragraph.
- c) Within 30 days the Commission shall hold a hearing in the proposed subdivision area for reviewing the subdivision petition and the proposed bylaws and boundaries. The Commission, after making any necessary findings shall approve or disapprove of the subdivision petition. If the subdivision petition is approved, then the Commission is authorized to make any amendments to the bylaws to satisfy Article III Section 2 of the Plan. The Commission is also authorized to make any amendments to the boundaries it deems necessary to preserve the integrity of the affected neighborhood council or councils and the subdivision.
 - ----> Is there any penalty or consequence for not complying with the 30-day requirement?
 - ----> This does not require the hearing to be within the proposed boundaries, which obviously might be difficult to accomplish depending on local facilities. But more significantly, it doesn't even require the hearing

to be held within the boundaries of any affected NC. If the intention is to hold a hearing within the boundaries of some combination of the proposed and existing NCs, that should be specified. ----> If BONC approves the petition but then makes changes in the boundaries or bylaws that are unacceptable to the petitioners, do the petitioners have any recourse other than campaigning to defeat the subdivision at the election (which at this point would not have been scheduled)? Is there any mechanism to withdraw the petition? Is there any mechanism to delay the process to make further changes?

d) The Department shall conduct an election within the boundaries stated in the subdivision petition ... To the extent possible the Departments shall also utilize polling locations within the boundaries of the effected certified **Neighborhood Councils** excluding the proposed subdivision area.

----> Why is there no requirement to have polls within the existing NC boundaries? This is a definite bias in favor of the proposed NC. Existing NCs have approved polling place(s) from their own previous elections, so the issue can't be that there is no appropriate place to hold an election. This is very unfair to the stakeholders in the existing Neighborhood Council(s).

----> It is affected NCs.

e) If the existing certified Neighborhood Council or Neighborhood Councils fail to provide amended bylaws within 60 days of the election certification then the Department is authorized to amend the bylaws to reflect any changes to the boundaries or board structure.

----> 60 days may not be adequate time for a newly reduced NC to make changes, especially if the board structure must be altered. For instance, if an existing NC has board members who represent specific areas and one or more areas are annexed to a new NC, the stakeholders of the existing NC should have adequate opportunity to have input before the board modifies the bylaws, including the basic structure. Depending on when the existing NC regularly meets, 60 days may not provide enough time for stakeholder input, board discussion and approval. There should be a minimum of 90 days to change the bylaws. Authorizing the department to amend bylaws without direct and adequate stakeholder input is not appropriate, especially if the only reason is an arbitrarily imposed time limit of 60 days.

The *Commissions* is authorized to make any amendments to the bylaws to satisfy Article III Section 2 of the Plan.

----> It is **Commission** (singular).
