

Downtown L.A. Neighborhood Council (DLANC) Ballot Voting Model

The DLANC Ballot Voting Model has 21 ballot types. Stakeholders can declare one (1) stakeholder status and will be issued one (1) ballot.

1) AT-LARGE DIRECTOR BALLOT

Stakeholders who are at least 16 years of age and claim any type of stakeholder status within the DLANC boundaries can only vote for the following race:

- At-Large Director - Vote for one (1)

2) ALAMEDA EAST RESIDENT DIRECTOR BALLOT

Stakeholders who are at least 16 years of age and reside within the Alameda East area within the DLANC boundaries can vote for the following races:

- Alameda East Resident Director - Vote for one (1)
- Area-Wide Resident Director - Vote for one (1)
- At-Large Director - Vote for one (1)

3) BUNKER HILL RESIDENT DIRECTOR BALLOT

Stakeholders who are at least 16 years of age and reside within the Bunker Hill area within the DLANC boundaries can vote for the following races:

- Bunker Hill Resident Director - Vote for one (1)
- Area-Wide Resident Director - Vote for one (1)
- At-Large Director - Vote for one (1)

4) CITY WEST RESIDENT DIRECTOR BALLOT

Stakeholders who are at least 16 years of age and reside within the City West area within the DLANC boundaries can vote for the following races:

- City West Resident Director - Vote for one (1)
- Area-Wide Resident Director - Vote for one (1)
- At-Large Director - Vote for one (1)

5) CIVIC CENTER RESIDENT DIRECTOR BALLOT

Stakeholders who are at least 16 years of age and reside within the Civic Center area within the DLANC boundaries can vote for the following races:

- Civic Center Resident Director - Vote for one (1)
- Area-Wide Resident Director - Vote for one (1)
- At-Large Director - Vote for one (1)

6) CENTRAL CITY EAST/SKID ROW RESIDENT DIRECTOR BALLOT

Stakeholders who are at least 16 years of age and reside within the Central City East/Skid Row area within the DLANC boundaries can vote for the following races:

- Central City East/Skid Row Resident Director - Vote for one (1)
- Area-Wide Resident Director - Vote for one (1)
- At-Large Director - Vote for one (1)

7) FASHION DISTRICT RESIDENT DIRECTOR BALLOT

Stakeholders who are at least 16 years of age and reside within the Fashion District area within the DLANC boundaries can vote for the following races:

- Fashion District Resident Director - Vote for one (1)
- Area-Wide Resident Director - Vote for one (1)
- At-Large Director - Vote for one (1)

8) HISTORIC DOWNTOWN RESIDENT DIRECTOR BALLOT

Stakeholders who are at least 16 years of age and reside within the Historic Downtown area within the DLANC boundaries can vote for the following races:

- Historic Downtown Resident Director - Vote for one (1)
- Area-Wide Resident Director - Vote for one (1)
- At-Large Director - Vote for one (1)

9) SOUTH PARK RESIDENT DIRECTOR BALLOT

Stakeholders who are at least 16 years of age and reside within the South Park area within the DLANC boundaries can vote for the following races:

- South Park Resident Director - Vote for one (1)
- Area-Wide Resident Director - Vote for one (1)
- At-Large Director - Vote for one (1)

10) AREA-WIDE HOMELESS DIRECTOR BALLOT

Stakeholders who are at least 16 years of age and self attest to homeless status and residency within the DLANC boundaries can vote for the following races:

- Area-Wide Homeless Resident Director - Vote for one (1)
- Area-Wide Resident Director - Vote for one (1)
- At-Large Director - Vote for one (1)

11) ALAMEDA EAST BUSINESS DIRECTOR BALLOT

Stakeholders who are at least 16 years of age and self attest business interests within the Alameda East area within the DLANC boundaries can vote for the following races:

- Alameda East Business Director - Vote for one (1)
- Area-Wide Business Director - Vote for one (1)
- At-Large Director - Vote for one (1)

12) CENTRAL CITY EAST/TOY DISTRICT BUSINESS DIRECTOR BALLOT

Stakeholders who are at least 16 years of age and self attest business interests within the Central City East/Toy District area within the DLANC boundaries can vote for the following races:

- Central City East/Toy District Business Director - Vote for one (1)
- Area-Wide Business Director - Vote for one (1)
- At-Large Director - Vote for one (1)

13) CITY WEST BUSINESS DIRECTOR BALLOT

Stakeholders who are at least 16 years of age and self attest business interests within the City West within the DLANC boundaries can vote for the following races:

- City West Business Director - Vote for one (1)
- Area-Wide Business Director - Vote for one (1)
- At-Large Director - Vote for one (1)

14) DOWNTOWN CENTER BUSINESS DIRECTOR BALLOT

Stakeholders who are at least 16 years of age and self attest business interests within the Downtown Center within the DLANC boundaries can vote for the following races:

- Downtown Center Business Director - Vote for one (1)
- Area-Wide Business Director - Vote for one (1)
- At-Large Director - Vote for one (1)

15) FASHION DISTRICT BUSINESS DIRECTOR BALLOT

Stakeholders who are at least 16 years of age and self attest business interests within the Fashion District within the DLANC boundaries can vote for the following races:

- Fashion District Business Director - Vote for one (1)
- Area-Wide Business Director - Vote for one (1)
- At-Large Director - Vote for one (1)

16) HISTORIC DOWNTOWN BUSINESS DIRECTOR BALLOT

Stakeholders who are at least 16 years of age and self attest business interests within the Historic Downtown within the DLANC boundaries can vote for the following races:

- Historic Downtown Business Director - Vote for one (1)
- Area-Wide Business Director - Vote for one (1)
- At-Large Director - Vote for one (1)

17) SOUTH PARK BUSINESS DIRECTOR BALLOT

Stakeholders who are at least 16 years of age and self attest business interests within the South Park area within the DLANC boundaries can vote for the following races:

- South Park Business Director - Vote for one (1)
- Area-Wide Business Director - Vote for one (1)
- At-Large Director - Vote for one (1)

18) ARTS, CULTURAL, AND EDUCATIONAL INTERESTS DIRECTORS BALLOT

Stakeholders with Arts, Cultural and Educational interests can vote for the following races:

- Arts, Cultural, and Educational Interests Directors - Vote for up to three (3)
- Arts, Cultural, and Educational Interests Director (Resident) - Vote for one (1)
- At-Large Director - Vote for one (1)

19) SOCIAL SERVICE PROVIDERS DIRECTORS BALLOT

Stakeholders with Social Services Provider interests can vote for the following races:

- Social Service Providers Directors - Vote for up to three (3)
- At-Large Director - Vote for one (1)

20) PUBLIC SECTOR WORKFORCE DIRECTOR BALLOT

Stakeholders with public workforce interests can vote for the following races:

- Public Sector Workforce Director - Vote for one (1)
- At-Large Director - Vote for one (1)

21) PRIVATE SECTOR WORKFORCE DIRECTOR BALLOT

Stakeholders with private workforce interests can vote for the following races:

- Private Sector Workforce Director - Vote for one (1)
- At-Large Director - Vote for one (1)

Summary:

- The DLANC has 28 Board seats. All **28** are elected.
- Stakeholders will use **documentation** as a means of establishing their stakeholder status.
- Minimum stakeholder voting age is **16**.
- The DLANC has eight (8) Residential Districts.
- The DLANC has seven (7) Business Districts.
- The DLANC Board has a two-year term.
- Candidates can run for no more than one Board seat.
- DLANC's business and residential districts differ.
