- The ERNC has 19 board seats. Only 18 are elected.
- Stakeholders will use Documentation as a means of establishing their stakeholder status.
- Minimum voting age is 16.
- The ERNC has eight (8) voting sub-districts within their boundaries.
- The ERNC Board has a two-year term.
- Candidates can run for no more than one Board seat.
