

Granada Hills South Neighborhood Council (GHSNC) Ballot Voting Model

The GHSNC Ballot Voting Model has 13 ballot types. Voters can qualify for multiple specific-seat categories.

1) MEMBER-AT-LARGE DIRECTORS BALLOT

Any Stakeholder who lives, works, or owns property in the neighborhood or who declare a stake in the neighborhood as a community interest stakeholder and who is 16 years or older can vote for the following race:

- Member-at-Large Directors - Vote for up to nine (9)

2) MEMBER-AT-LARGE COMMUNITY INTEREST DIRECTOR BALLOT

Stakeholder who declares a stake in the neighborhood as a community interest stakeholder and who is 16 years or older can vote for the following race:

- Member-at-Large Community Interest Director - Vote for one (1)

3) RENTERS DIRECTOR BALLOT

Any stakeholder who rents and resides in a home, condominium, townhouse, or apartment within the boundaries of the Neighborhood Council and who is 16 years or older can vote for the following race:

- Renters Director - Vote for one (1)

4) COMMUNITY ORGANIZATIONS DIRECTOR BALLOT

Any stakeholder who is a member of a community organization that regularly meets within the boundaries of the Neighborhood Council and who is 16 years or older can vote for the following race:

- Community Organizations Director - Vote for one (1)

5) COMMERCIAL PROPERTY OWNER DIRECTOR BALLOT

Any stakeholder who owns property that is zoned for commercial purposes within the boundaries of the Neighborhood Council and who is 16 years or older can vote for the following race:

- Commercial Property Owner Director - Vote for one (1)

6) FAITH-BASED GROUPS DIRECTOR BALLOT

Any stakeholder who is a member of a church, temple, mosque and other faith-based group that have facilities physically located within the boundaries the Neighborhood Council and who is 16 years or older can vote for the following race:

- Faith-Based Groups Director - Vote for one (1)

7) BUSINESS DIRECTOR BALLOT

Any stakeholder who owns or works for a business that is physically located within the boundaries of the Neighborhood Council, or from persons legally operating a business from their primary residences within the boundaries of the Neighborhood Council and who is 16 years or older can vote for the following race:

- Business Director - Vote for one (1)

8) HOMEOWNERS DIRECTOR BALLOT

Any stakeholder who owns and lives in a residential dwelling, condominium, townhouse, or apartment within the boundaries of the Neighborhood Council and who is 16 years or older can vote for following race:

- Homeowners Director - Vote for one (1)

9) PARKS & CULTURAL ARTS DIRECTOR BALLOT

Any stakeholder who is a member of a park organization or Cultural Arts organization, e.g., that libraries, historical societies, theater groups, museums, or organizations dedicated to enhancing music, arts or culture that meets at least four times a year or who lives within the boundaries of the Neighborhood Council and is a member of a parks organization or Cultural Arts organization that meets four times a year and who is 16 years or older can vote for the following race:

- Parks & Cultural Arts Director - Vote for one (1)

10) YOUTH ORGANIZATIONS DIRECTOR BALLOT

Any stakeholder who is a member of a youth-based organization whose meetings or activities are regularly held within the boundaries of the Neighborhood Council and who is 16 years or older can vote for the following race:

- Youth Organizations Director - Vote for one (1)

11) STUDENTS DIRECTOR BALLOT

Any stakeholder who is a student, ages 16 through 25, attending a school or residing within the boundaries of the Neighborhood Council can vote for the following race:

- Students Director - Vote for one (1)

12) EDUCATION DIRECTOR BALLOT

Any stakeholder who works (full or part-time) for a school, adult-school, day-care center, pre-school, or other educational group (an Educational Institution) located within the boundaries of the Neighborhood Council or who lives within the boundaries of the Neighborhood Council and works for any Educational Institution and who is 16 years or older can vote for the following race:

- Education Director - Vote for one (1)

13) SENIOR DIRECTOR BALLOT

Any stakeholder who resides within the boundaries of the Neighborhood Council and shall be at least 55 years old can vote for the following race:

- Senior Director - Vote for one (1)

Summary:

- The GHSNC has 21 board seats. All **21** are elected.
- Stakeholders will use **documentation** as a means of establishing their stakeholder status.
- Minimum stakeholder voting age is **16**.
- The GHSNC board has a two-year term.
- Candidates can run for more than one board seat.
