

Greater Valley Glen Council (GVGC) Ballot Voting Model

The GVGC Ballot Voting Model has 13 ballot types. Stakeholders can only claim one (1) stakeholder status and will be issued one (1) ballot.

1) COMMUNITY STAKEHOLDER BALLOT

Community Stakeholder who is 16 years of age or older at the time of the election, can vote for the following races:

- At-Large Community Stakeholder Representatives - Vote for up to two (2)
- Merchant/Businesspersons Representatives - Vote for up to four (4)
- Commercial Property Owner Representatives - Vote for up to two (2)

2) HOMEOWNER REPRESENTATIVE DISTRICT 1 BALLOT

Homeowner Stakeholder who is 16 years of age or older who lives within District 1 and owns and occupies a place of residence, can vote for the following races:

- Homeowner Representative District 1 - Vote for one (1)
- Resident Occupant Representative District 1 - Vote for one (1)
- At-Large Community Stakeholder Representatives - Vote for up to two (2)
- Merchant/Businesspersons Representatives - Vote for up to four (4)
- Commercial Property Owner Representatives - Vote for up to two (2)

3) HOMEOWNER REPRESENTATIVE DISTRICT 2 BALLOT

Homeowner Stakeholder who is 16 years of age or older who lives within District 2 and owns and occupies a place of residence can vote for the following races:

- Homeowner Representative District 2 - Vote for one (1)
- Resident Occupant Representative District 2 - Vote for one (1)
- At-Large Community Stakeholder Representatives - Vote for up to two (2)
- Merchant/Businesspersons Representatives - Vote for up to four (4)
- Commercial Property Owner Representatives - Vote for up to two (2)

4) HOMEOWNER REPRESENTATIVE DISTRICT 3 BALLOT

Homeowner Stakeholder who is 16 years of age or older who lives within District 3 and owns and occupies a place of residence can vote for the following races:

- Homeowner Representative District 3 - Vote for one (1)
- Resident Occupant Representative District 3 - Vote for one (1)
- At-Large Community Stakeholder Representatives - Vote for up to two (2)
- Merchant/Businesspersons Representatives - Vote for up to four (4)
- Commercial Property Owner Representatives - Vote for up to two (2)

5) HOMEOWNER REPRESENTATIVE DISTRICT 4 BALLOT

Homeowner Stakeholder who is 16 years of age or older who lives within District 4 and owns and occupies a place of residence can vote for the following races:

- Homeowner Representative District 4 - Vote for one (1)
- Resident Occupant Representative District 4 - Vote for one (1)
- At-Large Community Stakeholder Representatives - Vote for up to two (2)
- Merchant/Businesspersons Representatives - Vote for up to four (4)
- Commercial Property Owner Representatives - Vote for up to two (2)

6) HOMEOWNER REPRESENTATIVE DISTRICT 5 BALLOT

Homeowner Stakeholder who is 16 years of age or older who lives within District 5 and owns and occupies a place of residence can vote for the following races:

- Homeowner Representative District 5 - Vote for one (1)
- Resident Occupant Representative District 5 - Vote for one (1)
- At-Large Community Stakeholder Representatives - Vote for up to two (2)
- Merchant/Businesspersons Representatives - Vote for up to four (4)
- Commercial Property Owner Representatives - Vote for up to two (2)

7) HOMEOWNER REPRESENTATIVE DISTRICT 6 BALLOT

Homeowner Stakeholder who is 16 years of age or older who lives within District 6 and owns and occupies a place of residence can vote for the following races:

- Homeowner Representative District 6 - Vote for one (1)
- Resident Occupant Representative District 6 - Vote for one (1)
- At-Large Community Stakeholder Representatives - Vote for up to two (2)
- Merchant/Businesspersons Representatives - Vote for up to four (4)
- Commercial Property Owner Representatives - Vote for up to two (2)

8) RESIDENT OCCUPANT REPRESENTATIVE DISTRICT 1 BALLOT

Resident Occupant Stakeholder who is 16 years of age or older who lives in District 1 and rents, leases, or owns a place of residence can vote for the following race:

- Resident Occupant Representative District 1 - Vote for one (1)
- At-Large Community Stakeholder Representatives - Vote for up to two (2)
- Merchant/Businesspersons Representatives - Vote for up to four (4)
- Commercial Property Owner Representatives - Vote for up to two (2)

9) RESIDENT OCCUPANT REPRESENTATIVE DISTRICT 2 BALLOT

Resident Occupant Stakeholder who is 16 years of age or older who lives in District 2 and rents, leases, or owns a place of residence can vote for the following race:

- Resident Occupant Representative District 2 - Vote for one (1)
- At-Large Community Stakeholder Representatives - Vote for up to two (2)
- Merchant/Businesspersons Representatives - Vote for up to four (4)
- Commercial Property Owner Representatives - Vote for up to two (2)

10) RESIDENT OCCUPANT REPRESENTATIVE DISTRICT 3 BALLOT

Resident Occupant Stakeholder who is 16 years of age or older who lives in District 3 and rents, leases, or owns a place of residence can vote for the following race:

- Resident Occupant Representative District 3 - Vote for one (1)
- At-Large Community Stakeholder Representatives - Vote for up to two (2)
- Merchant/Businesspersons Representatives - Vote for up to four (4)
- Commercial Property Owner Representatives - Vote for up to two (2)

11) RESIDENT OCCUPANT REPRESENTATIVE DISTRICT 4 BALLOT

Resident Occupant Stakeholder who is 16 years of age or older who lives in District 4 and rents, leases, or owns a place of residence can vote for the following race:

- Resident Occupant Representative District 4 - Vote for one (1)
- At-Large Community Stakeholder Representatives - Vote for up to two (2)
- Merchant/Businesspersons Representatives - Vote for up to four (4)
- Commercial Property Owner Representatives - Vote for up to two (2)

12) RESIDENT OCCUPANT REPRESENTATIVE DISTRICT 5 BALLOT

Resident Occupant Stakeholder who is 16 years of age or older who lives in District 5 and rents, leases, or owns a place of residence can vote for the following race:

- Resident Occupant Representative District 5 - Vote for one (1)
- At-Large Community Stakeholder Representatives - Vote for up to two (2)
- Merchant/Businesspersons Representatives - Vote for up to four (4)
- Commercial Property Owner Representatives - Vote for up to two (2)

13) RESIDENT OCCUPANT REPRESENTATIVE DISTRICT 6 BALLOT

Resident Occupant Stakeholder who is 16 years of age or older who lives in District 6 and rents, leases, or owns a place of residence can vote for the following race:

- Resident Occupant Representative District 6 - Vote for one (1)
- At-Large Community Stakeholder Representatives - Vote for up to two (2)
- Merchant/Businesspersons Representatives - Vote for up to four (4)
- Commercial Property Owner Representatives - Vote for up to two (2)

Summary:

- The GVGC has 25 board seats. **Twenty** are elected.
- Stakeholders will use **self-affirmation** as a means of establishing their stakeholder status.
- Minimum stakeholder voting age is **16**.
- The GVGC board has a two-year term.
- Candidates can run for no more than one board seat.
