

Greater Wilshire Neighborhood Council (GWNC) Ballot Voting Model

The GWNC Ballot Voting Model 21 different ballot types. Stakeholders may vote for no more than one (1) area and no more than one (1) special interest.

1) SPECIAL INTEREST BOARD SEAT: AT LARGE STAKEHOLDER BALLOT

Stakeholders who live, work or own property and also those who declare a stake within the GWNC boundaries and affirm a factual basis for it can vote in the following race:

- At Large Representative – Vote for one (1)

2) AREA 1 STAKEHOLDER BALLOT

Stakeholders who live, work, or own property within the geographic Area 1 can vote in the following race:

- Geographic Area 1 Director – Vote for one (1)

3) AREA 2 STAKEHOLDER BALLOT

Stakeholders who live, work, or own property within the geographic Area 2 can vote in the following race:

- Geographic Area 2 Director – Vote for one (1)

4) AREA 3 STAKEHOLDER BALLOT

Stakeholders who live, work, or own property within the geographic Area 3 can vote in the following race:

- Geographic Area 3 Director – Vote for one (1)

5) AREA 4 STAKEHOLDER BALLOT

Stakeholders who live, work, or own property within the geographic Area 4 can vote in the following race:

- Geographic Area 4 Director – Vote for one (1)

6) AREA 5 STAKEHOLDER BALLOT

Stakeholders who live, work, or own property within the geographic Area 5 can vote in the following race:

- Geographic Area 5 Director – Vote for one (1)

7) AREA 6 STAKEHOLDER BALLOT

Stakeholders who live, work, or own property within the geographic Area 6 can vote in the following race:

- Geographic Area 6 Director – Vote for one (1)

8) AREA 7 STAKEHOLDER BALLOT

Stakeholders who live, work, or own property within the geographic Area 7 can vote in the following race:

- Geographic Area 7 Director – Vote for one (1)

9) AREA 8 STAKEHOLDER BALLOT

Stakeholders who live, work, or own property within the geographic Area 8 can vote in the following race:

- Geographic Area 8 Director – Vote for one (1)

10) AREA 9 STAKEHOLDER BALLOT

Stakeholders who live, work, or own property within the geographic Area 9 can vote in the following race:

- Geographic Area 9 Director – Vote for one (1)

11) AREA 10 STAKEHOLDER BALLOT

Stakeholders who live, work, or own property within the geographic Area 10 and can vote in the following race:

- Geographic Area 10 Director – Vote for one (1)

12) AREA 11 STAKEHOLDER BALLOT

Stakeholders who live, work, or own property within the geographic Area 11 can vote in the following race:

- Geographic Area 11 Director – Vote for one (1)

13) AREA 12 STAKEHOLDER BALLOT

Stakeholders who live, work, or own property within the geographic Area 12 can vote in the following race:

- Geographic Area 12 Director – Vote for one (1)

14) AREA 13 STAKEHOLDER BALLOT

Stakeholders who live, work, or own property within the geographic Area 13 can vote in the following race:

- Geographic Area 13 Director – Vote for one (1)

15) AREA 14 STAKEHOLDER BALLOT

Stakeholders who live, work, or own property within the geographic Area 14 can vote in the following race:

- Geographic Area 14 Director – Vote for one (1)

16) AREA 15 STAKEHOLDER BALLOT

Stakeholders who live, work, or own property within the geographic Area 15 can vote in the following race:

- Geographic Area 15 Director – Vote for one (1)

17) SPECIAL INTEREST BOARD SEAT: RENTER REPRESENTATIVE BALLOT

Stakeholders who rent and live but do not own property within the GWNC boundaries can vote in the following race:

- Renter Representative – Vote for one (1)

18) SPECIAL INTEREST BOARD SEAT: BUSINESS REPRESENTATIVE BALLOT

Stakeholders who are regular and ongoing participating representatives of a business or business association within the GWNC boundaries can vote in the following race:

- Business Representative – Vote for one (1)

19) SPECIAL INTEREST BOARD SEAT: EDUCATION REPRESENTATIVE BALLOT

Stakeholders who are regular and ongoing participating representatives of an educational institution within the GWNC boundaries can vote in the following race:

- Education Representative – Vote for one (1)

20) SPECIAL INTEREST BOARD SEAT: RELIGION REPRESENTATIVE BALLOT

Stakeholders who are regular and ongoing participating representatives of a religious organization within the GWNC boundaries can vote in the following race:

- Religion Representative – Vote for one (1)

21) SPECIAL INTEREST BOARD SEAT: OTHER NONPROFIT REPRESENTATIVE BALLOT

Stakeholders who are regular and ongoing participating representatives of a nonprofit organization within the GWNC boundaries can vote in the following race:

- Other Nonprofit Representative – Vote for one (1)

Summary:

- The GWNC has 21 board seats. All **21** are elected.
- Stakeholders will use **documentation** as a means of establishing their stakeholder status.
- Minimum stakeholder voting age is **18**.
- The GWNC has fifteen (15) voting areas within their boundaries.
- The GWNC Board has a two-year term.
- Candidates can run for no more than one board seat.
