## Mid City WEST Community Council (MCWCC) Ballot Voting Model

The MCWCC Ballot Voting Model has eight (8) ballot types. Stakeholders can only claim one (1) stakeholder status and will be issued one (1) ballot. Stakeholders must declare a resident stakeholder status to vote a zone ballot.

Stakeholders who live, work or own property in the MCWCC and also those who declare a stake in the neighborhood and affirm a factual basis for it and are at least 16 years of age at the time of the election can vote for the following races:

## Summary:

- MCWCC has 45 board seats. All 45 are elected.
- Stakeholders will use self-affirmation as a means of establishing their stakeholder status.
- Minimum stakeholder voting age is 16.
- The MCWCC has seven (7) Residential Zones.
- The MCWCC Board has a two-year term.
- Candidates can run for no more than one board seat.
- Factual basis stakeholders can only be issued the MCWCC Ballot.
- Except for the Zone Representatives, factual basis candidates can run in any of the MCWCC seats.
