# P.I.C.O. Neighborhood Council (P.I.C.O.) Ballot Voting Model

The P.I.C.O. Ballot Voting Model has 11 different ballot types. Stakeholders can only claim one (1) stakeholder status and will be issued one (1) ballot.

#### **Summary:**

- P.I.C.O. has 24 Board seats. **Twenty-one** are elected, but only **11** will be up for election in 2014 due to staggered board terms.
- Stakeholders will use **self-affirmation** as a means of establishing their stakeholder status.
- Minimum stakeholder voting age is 18.
- The P.I.C.O. Board has a staggered, four-year term.
- Candidates can run for no more than one board seat.
