## Palms Neighborhood Council (PNC) Ballot Voting Model

The PNC Ballot Voting Model has nine (9) different ballot types. Stakeholders can only claim one (1) stakeholder status and will be issued one (1) ballot.

## 1) AT-LARGE BALLOT

Stakeholder who lives, works, owns property or declares a stake in the PNC and affirms the factual basis for it and is 16 years or older, can vote for the following races:

- President - Vote for one (1)
- Vice President - Vote for one (1)
- Secretary - Vote for one (1)
- Treasurer - Vote for one (1)
- Community-Based Organization Representative - Vote for one (1)

2) RESIDENTIAL AREA A - PALMS WEST BALLOT

Stakeholder who is 16 years or older and who resides in Residential Area A, can vote for the following races:

- Residential Area A Representative - Vote for one (1)
- President - Vote for one (1)
- Vice President - Vote for one (1)
- Secretary - Vote for one (1)
- Treasurer - Vote for one (1)
- Community-Based Organization Representative - Vote for one (1)

3) RESIDENTIAL AREA B - OVERLAND BALLOT

Stakeholder who is 16 years or older and who resides in Residential Area B, can vote for the following races:

- Residential Area B Representative - Vote for one (1)
- President - Vote for one (1)
- Vice President - Vote for one (1)
- Secretary - Vote for one (1)
- Treasurer - Vote for one (1)
- Community-Based Organization Representative - Vote for one (1)


## 4) RESIDENTIAL AREA C - MOTOR BALLOT

Stakeholder who is 16 years or older and who resides in Residential Area C, can vote for the following races:

- Residential Area C Representative - Vote for one (1)

## 5) RESIDENTIAL AREA D - STUDIO BALLOT

Stakeholder who is 16 years or older and who resides in Residential Area D can vote for the following races:

- Community-Based Organization Representative - Vote for one (1)


## 6) RESIDENTIAL AREA E - EXPOSITION BALLOT

Stakeholder who is 16 years or older and who resides in Residential Area E, can vote for the following races:

- Residential Area E Representative - Vote for one (1)
- President - Vote for one (1)
- Vice President - Vote for one (1)
- Secretary - Vote for one (1)
- Treasurer - Vote for one (1)
- Community-Based Organization Representative - Vote for one (1)


## 7) BUSINESS AREA 1 - PACIFIC ELECTRIC BALLOT

Stakeholder who is 16 years or older and who works or owns a business in Business Area 1, can vote for the following races:

- Business Area 1 Representative - Vote for one (1)
- President - Vote for one (1)
- Vice President - Vote for one (1)
- Secretary - Vote for one (1)
- Treasurer - Vote for one (1)
- Community-Based Organization Representative - Vote for one (1)

8) BUSINESS AREA 2 - CHARNOCK RANCH BALLOT

Stakeholder who is 16 years or older and who works or owns a business in Business Area 2, can vote for the following races:

- Business Area 2 Representative - Vote for one (1)
- President - Vote for one (1)
- Vice President - Vote for one (1)
- Secretary - Vote for one (1)
- Treasurer - Vote for one (1)
- Community-Based Organization Representative - Vote for one (1)

9) BUSINESS AREA 3 - PALMS DEPOT BALLOT

Stakeholder who is 16 years or older and who works or owns a business in Business Area 3, can vote for the following races:

- Business Area 3 Representative - Vote for one (1)
- President - Vote for one (1)
- Vice President - Vote for one (1)
- Secretary - Vote for one (1)
- Treasurer - Vote for one (1)
- Community-Based Organization Representative - Vote for one (1)


## Summary:

- The PNC has 13 Board seats. All 13 are elected.
- Stakeholders will use Self-Affirmation as a means of establishing their stakeholder status.
- Minimum stakeholder voting age is 16.
- The PNC Board has a two-year term.
- Candidates can run for no more than one Board seat.
- Residential and business boundaries differ.
