Silver Lake Neighborhood Council (SLNC) Ballot Voting Model

The SLNC Ballot Voting Model has eight (8) different ballot types. Stakeholders can only claim one (1) stakeholder status and will be issued one (1) ballot.

1) AT-LARGE BALLOT

Stakeholders who live, work or own real property in the neighborhood and also those who declare a stake in the neighborhood as a community interest stakeholder, defined as a person who affirms a substantial and ongoing participation within the neighborhood council's boundaries and who may be in a community organization such as, but not limited to, educational, non-profit and/or religious organizations, and who are 14 years or older can vote for the following races:

- At-Large Representatives - Vote for up to seven (7)

2) REGION 1 REPRESENTATIVE BALLOT

Stakeholders who live, work or own real property in Region 1 and also those who declare a stake in Region 1 as a community interest stakeholder, defined as a person who affirms a substantial and ongoing participation within the Region 1 boundaries and who may be in a community organization such as, but not limited to, educational, non-profit and/or religious organizations, and who are 14 years or older can vote for the following races:

- At-Large Representatives Vote for up to seven (7)
- Region 1 Representatives Vote for up to two (2)

3) REGION 2 REPRESENTATIVE BALLOT

Stakeholders who live, work or own real property in Region 2 and also those who declare a stake in Region 2 as a community interest stakeholder, defined as a person who affirms a substantial and ongoing participation within the Region 2 boundaries and who may be in a community organization such as, but not limited to, educational, non-profit and/or religious organizations, and who are 14 years or older can vote for the following races:

- At-Large Representatives Vote for up to seven (7)
- Region 2 Representatives Vote for up to two (2)

4) REGION 3 REPRESENTATIVE BALLOT

Stakeholders who live, work or own real property in Region 3 and also those who declare a stake in Region 3 as a community interest stakeholder, defined as a person who affirms a substantial and ongoing participation within the Region 3 boundaries and who may be in a community organization such as, but not limited to, educational, non-profit and/or religious organizations, and who are 14 years or older can vote for the following races:

- At-Large Representatives Vote for up to seven (7)
- Region 3 Representatives Vote for up to two (2)

5) REGION 4 REPRESENTATIVE BALLOT

Stakeholders who live, work or own real property in Region 4 and also those who declare a stake in Region 4 as a community interest stakeholder, defined as a person who affirms a substantial and ongoing participation within the Region 4 boundaries and who may be in a community organization such as, but not limited to, educational, non-profit and/or religious organizations, and who are 14 years or older can vote for the following races:

- At-Large Representatives Vote for up to seven (7)
- Region 4 Representatives Vote for up to two (2)

6) REGION 5 REPRESENTATIVE BALLOT

Stakeholders who live, work or own real property in Region 5 and also those who declare a stake in Region 5 as a community interest stakeholder, defined as a person who affirms a substantial and ongoing participation within the Region 5 boundaries and who may be in a community organization such as, but not limited to, educational, non-profit and/or religious organizations, and who are 14 years or older can vote for the following races:

- At-Large Representatives Vote for up to seven (7)
- Region 5 Representatives Vote for up to two (2)

7) REGION 6 REPRESENTATIVE BALLOT

Stakeholders who live, work or own real property in Region 6 and also those who declare a stake in Region 6 as a community interest stakeholder, defined as a person who affirms a substantial and ongoing participation within the Region 6 boundaries and who may be in a community organization such as, but not limited to, educational, non-profit and/or religious organizations, and who are 14 years or older can vote for the following races:

- At-Large Representatives Vote for up to seven (7)
- Region 6 Representatives Vote for up to two (2)

8) REGION 7 REPRESENTATIVE BALLOT

Stakeholders who live, work or own real property in Region 7 and also those who declare a stake in Region 7 as a community interest stakeholder, defined as a person who affirms a substantial and ongoing participation within the Region 7 boundaries and who may be in a community organization such as, but not limited to, educational, non-profit and/or religious organizations, and who are 14 years or older can vote for the following races:

- At-Large Representatives Vote for up to seven (7)
- Region 7 Representatives Vote for up to two (2)

Summary:

- The SLNC has 21 board seats. All **21** are elected.
- Stakeholders will use **documentation** as a means of establishing their stakeholder status.
- Minimum stakeholder voting age is **14**.
- The SLNC Board has a two-year term.
- Candidates can run for no more than one board seat.
