At-Large board member and At-Large Candidate Amy Clarke, has posted the photo of a current candidate, John Wingler, on the Silver Lake Neighborhood Council Facebook, via the councils website. Ms. Clarke not only posted the candidates photo, she also included a criticism of the board decision on the board resolution. A resolution which Mr. Wingler spoke against during the March 5th governing board meeting.

I believe Ms. Clarke has violated DONE's Candidate Guidelines #3, "You shall not use the City of Los Angeles Seal or Letterhead, the

Department of Neighborhood Empowerment (Department) Logo, the Office of the City Clerk Logo, the NC Logo, or any other official NC designation created by the Department." and #6, "You shall not use City facilities, equipment, supplies or other City resources for campaigning activities."

I am requesting that DONE handle these violation immediately. Please look below.

Good afternoon Grayce;

The Silver Lake Neighborhood Council Facebook page is registered with the Neighborhood Council. The NC has paid for the Facebook advertising using city funds. Ms. Clarke does not have sole control but I believe she is one of the administrators and she posted as herself in a comment on the board post, as you can see in the screen shot below. Ms. Clarke has declared on more than one occasion that she is extremely web/computer savvy, so she is not ignorant to the choices one can make when selecting and posting a photo on the page. Ms. Clarke selected a candidate photo to go with her link to <http://empowerla.org/slnc/silver-lake-nc-2014-elections/>.

Please look carefully at the screen shot and you will clearly see the city seal and the SLNC's logo. This is a violation and it is the responsibility of DONE to follow its own Candidate Guidelines and inform Ms. Clarke of the violation.

If this is not a violation of Rule #3 and/or #6, and all candidates can do as Ms. Clarke did, then I suggest an email from Empower LA be sent to all candidates immediately to inform us of our right to campaign in this fashion on the SLNC Facebook page.
