Ballot Voting Model

The V9NC Ballot Voting Model has five (5) different ballot types. Stakeholders can claim one (1) stakeholder status and will be issued one (1) ballot.

1) GENERAL BALLOT

Stakeholders who live, work, or own property in the neighborhood or declare a stake in the neighborhood and affirm the factual basis for it and who are 16 years or older can vote for the following races:

- Chairperson - Vote for one (1)
- Vice Chairperson - Vote for one (1)
- Treasurer - Vote for one (1)
- Recording Secretary - Vote for one (1)
- Corresponding Secretary - Vote for one (1)
- Parliamentarian - Vote for one (1)
- At-Large Representative - Vote for one (1)
- Community-Based/Non Profit Organizations Representative - Vote for one (1)
- Faith-Based Representative - Vote for one (1)
- Education Representative - Vote for one (1)

2) AREA 1 STAKEHOLDER BALLOT

Stakeholders who live, work, or own property within Area 1 and who are 16 years or older can vote for the following races:

- Area 1 Representative - Vote for one (1)

Summary:

- The V9NC has 15 board seats. Only **14** are elected.
- Stakeholders will use **self-affirmation** as a means of establishing their stakeholder status.
- Minimum stakeholder voting age is **16**.
- The V9NC Board has a two-year term.
- Candidates can run for no more than one Board seat.
