The WNC Ballot Voting Model has 5 ballot types. Stakeholders can claim one (1) stakeholder status and will be issued one (1) ballot.

1) AREA 2 REPRESENTATIVE BALLOT

Stakeholders who reside or declare stakeholder affiliation in the area and are at least 14 years of age at the time of the election can vote for the following races:

- Faith Based Organizations Representative Vote for one (1)
- Recreation, Culture & the Arts Representative Vote for one (1)
- Community Based Organizations Representative Vote for one (1)
- Transportation Representative Vote for one (1)
- Adults, Parents and Caregivers Representative Vote for one (1)

2) AREA 4 REPRESENTATIVE BALLOT

Summary:

- The WNC has 21 Board seats. **Twenty-one** are elected, but only **10** will be up for election in 2014 due to staggered board terms.
- Stakeholders will use **self-affirmation** as a means of establishing their stakeholder status.
- Minimum stakeholder voting age is **14**.
- The WNC has a staggered, four-year term.
- Candidates can run for no more than one Board seat.
