

Westwood Neighborhood Council (WWNC) Ballot Voting Model

The WWNC Ballot Voting Model has three (3) ballot types. Stakeholders can only claim one (1) stakeholder status and will be issued one (1) ballot.

1) WWNC OWNER RESIDENTIAL GROUP BALLOT

Stakeholders who live, work, own property or declare a stake within the WWNC boundaries and affirm the factual basis for it and who are 17 years or older, can only vote for the following races:

- Seat 1, Seat 2, Seat 3 and Seat 4: Owner Residential Group Directors – Vote for one (1)
- Seat 13: Student Director – Vote for one (1)
- Seat 14: Faculty or Staff Director – Vote for one (1)
- Seat 15: Educational Community Director – Vote for one (1)
- Seat 16: Non-Profit/Arts/Culture/Recreational Community Director – Vote for one (1)
- Seat 17: Faith Based Community Director – Vote for one (1)
- At Large Directors – Vote for up to two (2)

2) WWNC RENTAL RESIDENTIAL GROUP BALLOT

Stakeholders who live, work, own property or declare a stake within the WWNC boundaries and affirm the factual basis for it and who are 17 years or older, can only vote for the following races:

- Seat 5, Seat 6, Seat 7 and Seat 8: Rental Residential Group Directors – Vote for one (1)
- Seat 13: Student Director – Vote for one (1)
- Seat 14: Faculty or Staff Director – Vote for one (1)
- Seat 15: Educational Community Director – Vote for one (1)
- Seat 16: Non-Profit/Arts/Culture/Recreational Community Director – Vote for one (1)
- Seat 17: Faith Based Community Director – Vote for one (1)
- At Large Directors – Vote for up to two (2)

3) WWNC BUSINESS GROUP BALLOT

Stakeholders who live, work, own property or declare a stake within the WWNC boundaries and affirm the factual basis for it and who are 17 years or older, can only vote for the following races:

- Seat 9, Seat 10, Seat 11 and Seat 12: Business Group Directors – Vote for one (1)
- Seat 13: Student Director – Vote for one (1)
- Seat 14: Faculty or Staff Director – Vote for one (1)
- Seat 15: Educational Community Director – Vote for one (1)
- Seat 16: Non-Profit/Arts/Culture/Recreational Community Director – Vote for one (1)
- Seat 17: Faith Based Community Director – Vote for one (1)
- At Large Directors – Vote for up to two (2)

Summary:

- The WWNC has 19 board seats. All **19** are elected.
- Stakeholders will use **Self-Affirmation** as a means of establishing their stakeholder status.
- Minimum stakeholder voting age is **17**.
- The WWNC Board has a two-year term.
- Candidates can run for no more than one Board seat.
