Wilshire Center-Koreatown Neighborhood Council (WCKNC) Ballot Voting Model

The WCKNC Ballot Voting Model has seven (7) ballot types.

1) GENERAL BALLOT

Stakeholders who live, work, own property or declare a stake and affirm a factual basis for and who are 18 years or older can vote for the following races:

- At-Large Representative Vote for one (1)
- Community Organization Representatives Vote for up to seven (7)
- Business Representatives Vote for up to seven (7)
- Latino Representatives Vote for up to two (2)

2) YOUTH BALLOT

Stakeholders who live, work, own property or declare a stake and affirm a factual basis for and who are 18-24 years old can vote for the following race:

Young-Adult Representative - Vote for one (1)

3) SUB-DISTRICT 1 RESIDENT REPRESENTATIVE BALLOT

Any Stakeholder who resides within Sub-District 1 and who is 18 years or older can vote for the following races:

- Sub-District 1 Resident Representative Vote for one (1)
- At-Large Residential Representative Vote for one (1)
- At-Large Representative Vote for one (1)
- Community Organization Representatives Vote for up to seven (7)
- Business Representatives Vote for up to seven (7)
- Latino Representatives Vote for up to two (2)

4) SUB-DISTRICT 2 RESIDENT REPRESENTATIVE BALLOT

Any Stakeholder who resides within Sub-District 2 and who is 18 years or older can vote for the following races:

- Sub-District 2 Resident Representative Vote for one (1)
- At-Large Residential Representative Vote for one (1)
- At-Large Representative Vote for one (1)
- Community Organization Representatives Vote for up to seven (7)
- Business Representatives Vote for up to seven (7)
- Latino Representatives Vote for up to two (2)

5) SUB-DISTRICT 3 RESIDENT REPRESENTATIVE BALLOT

Any Stakeholder who resides within Sub-District 3 and who is 18 years or older can vote for the following races:

- Sub-District 3 Resident Representative Vote for one (1)
- At-Large Residential Representative Vote for one (1)
- At-Large Representative Vote for one (1)
- Community Organization Representatives Vote for up to seven (7)
- Business Representatives Vote for up to seven (7)
- Latino Representatives Vote for up to two (2)

6) SUB-DISTRICT 4 RESIDENT REPRESENTATIVE BALLOT

Any Stakeholder who resides within Sub-District 4 and who is 18 years or older can vote for the following races:

- Sub-District 4 Resident Representatives Vote for two (2)
- At-Large Residential Representative Vote for one (1)
- At-Large Representative Vote for one (1)
- Community Organization Representatives Vote for up to seven (7)
- Business Representatives Vote for up to seven (7)
- Latino Representatives Vote for up to two (2)

7) SUB-DISTRICT 5 RESIDENT REPRESENTATIVE BALLOT

Any Stakeholder who resides within Sub-District 5 and who is 18 years or older can vote for the following races:

- Sub-District 5 Resident Representatives Vote for two (2)
- At-Large Residential Representative Vote for one (1)
- At-Large Representative Vote for one (1)
- Community Organization Representatives Vote for up to seven (7)
- Business Representatives Vote for up to seven (7)
- Latino Representatives Vote for up to two (2)

Summary:

- The WCKNC has 26 Board seats. All **26** are elected.
- Stakeholders will use **documentation** as a means of establishing their stakeholder status.
- Minimum stakeholder voting age is **18**.
- The WCKNC Board has a two-year term.
- Candidates can run for no more than one Board seat.
