# Woodland Hills – Warner Center Neighborhood Council (WHWCNC) Ballot Voting Model

The WHWCNC Ballot Voting Model shall have eight (8) different ballots. Stakeholders can only claim one (1) stakeholder status and will be issued one (1) ballot.

## 1) AT-LARGE STAKEHOLDER REPRESENTATIVE BALLOT

All voting stakeholders at each election, regardless of the Area with which the stakeholder is identified for purposes of voting on the other three seats in that Council Area, who are at least 18 years old at the time of the election, can vote for At-Large Representative. Also, those stakeholders who live, work or own property or declare a stake in the neighborhood and affirm the factual basis for it can only vote in the following race:

At-Large Stakeholder Representative – Vote for one (1)

## 2) AREA 1 STAKEHOLDER BALLOT

A Stakeholder who is at least 18 years old at the time of the election and lives, works, owns a business, or is a member or participates in a community based organization within Area 1 can vote for the following races:

- Residential Stakeholder Representative of Area 1 Vote for one (1)
- Business Stakeholder Representative of Area 1 Vote for one (1)
- Community Based Organization Representative of Area 1 Vote for one (1)
- At-Large Stakeholder Representative Vote for one (1)

# 3) AREA 2 STAKEHOLDER BALLOT

A Stakeholder who is at least 18 years old at the time of the election and lives, works, owns a business, or is a member or participates in a community based organization within Area 2 can vote for the following races:

- Residential Stakeholder Representative of Area 2 Vote for one (1)
- Business Stakeholder Representative of Area 2 Vote for one (1)
- Community Based Organization Representative of Area 2 Vote for one (1)
- At-Large Stakeholder Representative Vote for one (1)

#### 4) AREA 3 STAKEHOLDER BALLOT

A Stakeholder who is at least 18 years old at the time of the election and lives, works, owns a business, or is a member or participates in a community based organization within Area 3 can vote for the following races:

- Residential Stakeholder Representative of Area 3 Vote for one (1)
- Business Stakeholder Representative of Area 3 Vote for one (1)
- Community Based Organization Representative of Area 3 Vote for one (1)
- At-Large Stakeholder Representative Vote for one (1)

## 5) AREA 4 STAKEHOLDER BALLOT

A Stakeholder who is at least 18 years old at the time of the election and lives, works, owns a business, or is a member or participates in a community based organization within Area 4 can vote for the following races:

- Residential Stakeholder Representative of Area 4 Vote for one (1)
- Business Stakeholder Representative of Area 4 Vote for one (1)
- Community Based Organization Representative of Area 4 Vote for one (1)
- At-Large Stakeholder Representative Vote for one (1)

## 6) AREA 5 STAKEHOLDER BALLOT

A Stakeholder who is at least 18 years old at the time of the election and lives, works, owns a business, or is a member or participates in a community based organization within Area 5 can vote for the following races:

- Residential Stakeholder Representative of Area 5 Vote for one (1)
- Business Stakeholder Representative of Area 5 Vote for one (1)
- Community Based Organization Representative of Area 5 Vote for one (1)
- At-Large Stakeholder Representative Vote for one (1)

# 7) AREA 6 STAKEHOLDER BALLOT

A Stakeholder who is at least 18 years old at the time of the election and lives, works, owns a business, or is a member or participates in a community based organization within Area 6 can vote for the following races:

- Residential Stakeholder Representative of Area 6 Vote for one (1)
- Business Stakeholder Representative of Area 6 Vote for one (1)
- Community Based Organization Representative of Area 6 Vote for one (1)
- At-Large Stakeholder Representative Vote for one (1)

#### 8) AREA 7 STAKEHOLDER BALLOT

A Stakeholder who is at least 18 years old at the time of the election and lives, works, owns a business, or is a member or participates in a community based organization within Area 7 can vote for the following races:

- Residential Stakeholder Representative of Area 7 Vote for one (1)
- Business Stakeholder Representative of Area 7 Vote for one (1)
- Community Based Organization Representative of Area 7 Vote for one (1)
- At-Large Stakeholder Representative Vote for one (1)

#### **Summary:**

- The WHWCNC has 22 board seats. All **22** are elected.
- Stakeholders will use **documentation** as a means of establishing their stakeholder status.
- Minimum stakeholder voting age is 18.
- The WHWCNC has seven (7) voting districts.
- The WHWCNC Board has a two-year term.
- Candidates can run for no more than one Board seat.
