Department of Neighborhood Empowerment (D.O.N.E.) comments: Raquel Beltrán, General Manager acknowledged these are challenging and unprecedented times in our City, State and nation. The death of Mr. George Floyd has continued to expose our countries' deep rooted institutional racism that plagues our nation. We see you, we hear you, and we stand with those expressing concerns about all of these issues. Thanked the Board of Neighborhood Commissioners and the Neighborhood Council System for all that they do to empower communities across the City of Los Angeles. The City and the department still has COVID-19 pandemic to manage. The department continues to work with neighborhood councils to support virtual governance meetings that we launched in May 2020. The first EmpowerLA Friday meeting, with

neighborhood council presidents, chair and co-chairs will be held on Friday, June 5, 2020 at 6pm virtually with General Manager, Raquel Beltrán. Future EmpowerLA Friday meetings will include neighborhood council board members. The department is in the process of moving forward to the next iteration of Empower Virtual Governance (EVG) protocols. The department has created a map of all neighborhood councils that conducted meetings in the month of May 2020. The EVG protocols allowed the department to provide quality direct neighborhood council support. In the month of April 2020 we had over eight hundred (800) neighborhood council leaders participated in the Roberts Rules webinars, and in the trainings for how to run virtual meetings. Those webinars and trainings were open to the public and were advertised on the department website and department newsletter. The next iteration of Roberts Rules is tentatively scheduled for July 27, 2020, with a focus on the role of presidents and executive committees. Over fifty-three (53) percent of participants of the webinar and trainings in April reported that they have visited the portal to strengthen their governance and Roberts Rules. The department had purchased a license for every board member on Roberts Rule and is good for another year. A survey will be sent to board members in order to shape the curriculum for the last Roberts Rules training. A special session on Roberts Rules and parliamentary governance just for the Neighborhood Empowerment Advocates will be held to build their skills. We know that communication and outreach is a big point of interest for neighborhood council leaders and stakeholders. Twenty (20) percent of you told us that during the listening tour and continue to do so. Under the leadership of Thomas Soong and his team we have completed four (4) out of seven (7) regional meetings with outreach committee chairs. We have brought in Momentum Solution experts in the area of outreach and communication to create tools for neighborhood councils could use to promote themselves and also communicate with stakeholders about how they can best engage with their neighborhood councils in this virtual environment. Thanked colleagues in the Office of the City Attorney Office for our first Virtual Ethics Training on Friday, May 29, 2020 with over eighty (80) participants. Thanked the HENPAR Committee lead by Councilmember David Ryu, approved the ordinances related to creating a clear definition on community interest stakeholders, and also an ordinance citing of the minimum age of neighborhood council board members, the age range for youth board members fourteen (14) to seventeen (17), and establishing the number of youth seats that can be dedicated in the bylaws. The deadline for neighborhood councils to update bylaws is Friday, June 5, 2020. The reason for the deadline is due to the requirement by the Office of the City Clerk to have all bylaws updated by July 1, 2020. The department doesn't expect to see any changes in the budget that the Mayor has proposed for Fiscal Year 2020-2021. The department has gone from thirty-five (35) employees to currently twenty-nine (29) in the department. In September 2019 the department had a budget of three point eight million (3,800,000) dollars and now the budget for next fiscal year is two point five million (2,500,000) dollars. Of the twenty-nine (29) employees we have in the department forty (40) percent of us are participating in the Disaster Service Worker (DSW) Program. Effective July 1, 2020 we will all be implementing mandatory furloughs with each employee being off one (1) day work day per pay period, so two (2) days a month for each employee while participating in the DSW program. Moving forward the City's financial position has become much more severe with the civil unrests in the past few days. The City will have to make decisions about revenue sources that will have to be utilized from the reserves including the emergency reserves. We have advised the City Council that the department will not be able to provide support to neighborhood council alliances, and will not be able to be as active in some of the areas that neighborhood councils would like us too. The department continues to practice Stay at Home in Phase 2 of the City Stay at Home Order.
