Department of Neighborhood Empowerment (D.O.N.E.) comments: Raquel Beltrán, General Manager acknowledged Director of Operations, Semee Park in attendance. The Listening Tour is at eighty-three neighborhood councils visited. Preliminary Listening Tour data has been presented to the HENPAR Committee in addition to following up on the twelve reforms. The report on the twelve reforms provides the status on the reforms that have been completed, are in progress and those that require long term strategies. Neighborhood council bylaws are under amendment now and this period will close in April 2020. The department will return to the HENPAR Committee with a report on the 2019 Neighborhood Council Elections Outreach and to discuss how we plan to implement, repeat or revise outreach for the 2021 Neighborhood Council Elections. The Listening Tour feedback is showing that most neighborhood councils have a need for outreach at all times not just related to elections. Currently, the department has a vacancy for a Neighborhood Empowerment Advocate (NEA) in the Harbor Area. The department has just received notice that NEA, Brett Shears will be transitioning out of the department in two weeks. NEA, Adriana Cabrera is on medical leave for a couple of weeks. The department had a Strategy meeting on how the neighborhood councils will be supported. Thanked Ms. Semee Park and her staff for a successful Galentines Event on February 10, 2020. The Office of Community Engagement had a great Data Literacy Workshop in Pacoima last week. Thanked Commissioner Vo-Ramirez for attending the workshop and supporting the neighborhood councils. The next Data Literacy Workshop will be in Spanish and is the only Spanish session. The next Homelessness Liaison Committee meeting is scheduled for March 31, 2020, City Hall East, with Controller Ron Galperin as a guest speaker. The next LGBTQ+ Alliance meeting is scheduled for March 18, 2020 at the Los Angeles LGBT Center. Ethics Training is scheduled for March 16, 2020 at Glassell Park Senior Citizen Center. The department has worked to share information with neighborhood councils regarding voting centers and thanked the neighborhood councils for posting and sharing the information with the public. A decision has been made at the department Van Nuys Office to lock both doors and post Restricted Area – Employees Only (Knock for Entry) signs. This is due to an individual entering employee areas dressed head to toe in black tactical gear and pointing cameras at staff in an aggressive manner. A successful Emergency Preparedness Liaison meeting was held on Saturday February 29, 2020. The department is expected to develop five Ready Your Los Angeles Neighborhood (RYLAN) plans per neighborhood council.

EXHAUSTION OF ADMINISTRATIVE REMEDIES:

If you challenge these agenda items in court, you may be limited to raising only those issues you or someone else raised at the public hearing or in written correspondence on these matters delivered to this agency at or prior to the public hearing. California Code of Civil Procedure Section 1094.6 governs the time in which a party may seek judicial review of this determination. Under that provision, a petitioner may seek judicial review of any decision of the City pursuant to California Code of Civil Procedure Section 1094.5 only if the petition for Writ of Mandate pursuant to that section is filed no later than the 90th day following the date on which the City's decision became final.

RECONSIDERATION:

The Commission may make a MOTION TO RECONSIDER and alter its action taken on any item listed on this agenda at any time during this meeting, or make a MOTION TO RECONSIDER at its next regular meeting as indicated below:

If the Commission moves and approves a Motion for Reconsideration at the *initial* meeting wherein an action was taken, then the underlying item may be reconsidered at that time.

If the Commission moves and approves a Motion for Reconsideration at *the next regular meeting* then consideration of the item may *only* occur at this regularly scheduled meeting if the item for consideration has been placed on that meeting's agenda.
