Department of Neighborhood Empowerment (D.O.N.E.) comments: Raquel Beltrán, General Manager reported we have appreciated the patience of the community during this unprecedented time. The department has been working to prepare and move the Neighborhood Council System into a virtual meeting environment. On April 8, 2020 the Department provided an update to neighborhood councils, describing the impact on the Neighborhood Council System. Previous letters regarding the impact on the Neighborhood Council System meetings were sent on March 12, 2020 and March 27, 2020. The April 8th letter informed board members of the department preparing to shift neighborhood council board meetings to a virtual meeting environment beginning on May 1, 2020. Since the Mayor issued the declaration of emergency of on March 4, 2020 the department has made an effort to support neighborhood council presidents, chairs, and board members. Our mission during this period of time has been to assist neighborhood councils to seek accurate information about

the emergency, provide neighborhood councils tools that could be shared with their communities and in accordance with the Mayor's Executive Orders to stay safe, "Safer at Home". The current emergency required changes not only to the day to day operations of the City of Los Angeles, but also the State and City public meeting roles. Those changes included considerations that could be given to jurisdictions in the State to hold public meetings using virtual platforms. That impacted the Neighborhood Council System and concurrently the Department's entire operation. One of the responsibilities of the department is to find and to plan for a citywide system of neighborhood councils, implement and oversee compliance with City ordinances and regulations related to the Neighborhood Council System. At this time there are no regulations or procedures associated with a uniform administration of virtual meetings. The department is creating those procedures. The department has launched an industrious effort to develop new protocols for neighborhood council meetings while we ourselves are following the Mayor's 'Safer at Home' Executive Order. The EmpowerLA Virtual Governance Plan and the related training for the plan involves researching City procedures and protocols for the City Council, City Boards and Commission meetings and adapting them to the Neighborhoo Council System. We have identified resources to train presidents, chairs, and board members on how to run successful virtual meetings. We have created a portal with resources, tools and online trainings that you will be able to use and continue to use after the COVID-19 pandemic. The later addresses a priority request from board members during the Neighborhood Council Listening Tour. The department is developing a process to enable neighborhood councils to hold virtual meetings using City approved platforms. We are drafting procedures, protocols and instructions on the management of virtual meetings adapted from those created for the City Council. We are developing an EmpowerLA Virtual Governance Training to support your transition to a virtual meeting model. The projected launch of the Neighborhood Council Virtual Governance System is May 1, 2020. Until the EmpowerLA Virtual Governance Plan is implemented system-wide, the department is limiting its direct neighborhood council support and will not be able to provide support to neighborhood council meetings at this time. This was communicated early on, to the Neighborhood Council System on March 27, 2020, advising what limitations the department had as it related to providing direct neighborhood council support. The Neighborhood Empowerment Advocates have been working to continue to provide support in areas we thought were manageable during this pandemic. We are going to continue to provide that level of support for board members needing assistance with the completion of mandatory trainings (Code of Conduct, Funding and Ethics), assist presidents and chairs with the development of their plan submittals for the use of now five thousand dollars (\$5,000.00) in emergency funds, to keep boards apprised of the City Council meetings, and to assist with management of temporary bylaws advisory committees. We have received City Council approval to consider rolling the balance of funds that may exist in neighborhood council accounts at the end of the current fiscal year. At the April 7, 2020 City Council meeting Councilmember David Ryu along with Councilmember Paul Koretz and Mike Bonin introduced a motion which was seconded by Councilmember Marqueece Harris-Dawson instructing the City Clerk and the Department of Neighborhood Empowerment to allow neighborhood councils to rollover the entire remaining balance each neighborhood council might have at the end of the fiscal year. If that is approved, as of today's report, the this would represent two point five million dollars (\$2,500,000.00) for neighborhood councils that would be rolled over into the next fiscal year. The department is tracking the activities of the neighborhood councils. What was heard today is a small representation of the fabulous work that neighborhood councils have been doing since the beginning of the pandemic. Before the Commission today is a request for approval of the Neighborhood Council Virtual Governance Training. A brief timeline of the work that has been done begins with the March 4, 2020 declared emergency by Mayor Garcetti. On March 17, 2020 we held a webinar with all neighborhood council board members. We were the first in the City to use the Zoom platform and were happy to secure the support of Mayor Garcetti who was very interested in having communication with the Neighborhood Council System and was generous with his time at this webinar. Two (2) days later on March 19, 2020 we began transitioning the entire department to telecommuting and during that period of time we held our first Round Table with the neighborhood council presidents in South Los Angeles. On March 19, 2020 we started creating

a tracking system to log the work of the neighborhood council volunteer hours and the support they are giving their communities. On March 27, 2020, we secured approval of the release of almost half a million dollars (\$500,000.00) to the Neighborhood Council System by virtue of increasing the authority of presidents during times of a declared emergency. Also, on March 27, 2020 we sent communication to the neighborhood councils explaining what our operational limitations were going to be as it related to not being able to support neighborhood council board meetings until we could establish a uniform virtual meeting system for the neighborhood councils. We also defined in that communication the level of support that we would be able to provide. On April 2, 2020 we received the Information Technology Agency recommendations for holding virtual meetings for City Commissions and the City Council. On April 7, 2020 we secured support from City Council to at least consider rolling over funds into the next fiscal year. On April 9, 2020 we piloted the Virtual Governance Training covering how to manage a successful virtual meeting using parliamentary procedures in a Brown Act environment. We have adapted the Information Technology Agency protocols to draft and design the EmpowerLA Virtual Governance Plan and related protocols for the Neighborhood Council System. Today we are having the first meeting of the Board of Neighborhood Commissioners with the assistance of staff on the back end and by providing individual support and training to each of the commissioners. It is our hope that if Agenda Item 11 is approved that we would launch the training process by first sending a survey to neighborhood council board members that would be used to inform us about the kind of support they would like to receive from the department. What we have heard today during public comment mirrors what our assumptions were when we began to develop a virtual governance plan. The trainings we want to have will provide two (2) trainings for neighborhood councils (1 morning session and 1 evening session) followed by a training specifically for boards and chairs. The EmpowerLA Virtual Governance Plan is based on seven (7) guiding principles: 1. Understand global efforts are concurrently focused on lessening the spread and will continue to be the case for months to come, 2 The pandemic has forever changed experiences for customers, employees, and communities, 3 Once the immediate threat of the virus has passed we'll need to assess how the virus has changed how we think and behave, 4 During Neighborhood Council 2019-2020 Listening Tour a survey was sent to eighty-nine (89) neighborhood council boards, a combined 47% of board members identified Governance & Parliamentary Training and Outreach Support as being the highest priority you have and what you would like to see from the department, 5 Consideration can be given to the various technology applications that can be selected for the administration of virtual meetings. The technology selected by the Information Technology Agency is Zoom, 6 There are varying levels of comfort, accessibility, and familiarity with tech tools. Adequate training and clear guidance will be required to ensure equitable access to the neighborhood council virtual meetings, 7 Effective communication strategies are necessary to engage residents in neighborhood council virtual meetings. These are the guiding principles of the plan. We have transitions taking place in the Department. Sevak Paramazian has accepted a promotion at the Personnel Department. When he leaves the department will have zero systems personnel. Brett Shears will also be leaving the department. The department has three (3) employees or ten percent (10%) of the staff working as Disaster Service Workers. The department is currently operating at seventy percent (70%) capacity. We have been doing the best job that we can and appreciate all of the support of the board members, employees and Commissioners. The Mayor's Office is aware of and regulary asks about the work of the neighborhood councils during this pandemic. The Mayor's State of the City will be broadcast at 5pm on Sunday, April 19, 2020.

#### FINALIZATION OF BOARD ACTION:

Per City Charter Section 245, the Board's determination shall become final at the expiration of the next five meeting days of the Council during which the City Council has convened in regular session, unless the City Council acts within that timeframe by a two-thirds vote to bring the action before them or to waive review of the action.

#### **EXHAUSTION OF ADMINISTRATIVE REMEDIES:**

If you challenge these agenda items in court, you may be limited to raising only those issues you or someone else raised at the public hearing or in written correspondence on these matters delivered to this agency at or prior to the public hearing. California Code of Civil Procedure Section 1094.6 governs the time in which a party may seek judicial review of this determination. Under that provision, a petitioner may seek judicial review of any decision of the City pursuant to California Code of Civil Procedure Section 1094.5 only if the petition for Writ of Mandate pursuant to that section is filed no later than the 90th day following the date on which the City's decision became final.

#### RECONSIDERATION:

The Commission may make a MOTION TO RECONSIDER and alter its action taken on any item listed on this agenda at any time during this meeting, or make a MOTION TO RECONSIDER at its next regular meeting as indicated below:

If the Commission moves and approves a Motion for Reconsideration at the *initial* meeting wherein an action was taken, then the underlying item may be reconsidered at that time.

If the Commission moves and approves a Motion for Reconsideration at the next regular meeting then consideration of the item may only occur at this regularly scheduled meeting if the item for consideration has been placed on that meeting's agenda. If the underlying item for reconsideration has not been placed on the agenda for that next regular meeting, then it shall be considered at a subsequent meeting pursuant to the Ralph M. Brown Act.
