#### Comment regarding "fair and equitable" NC funding allocation

Greetings,

I serve on the Atwater Village Neighborhood Council. My comments here are my own, not reflective of any position adopted by the AVNC.

While I feel that the City has done us all a great disservice by further cutting Neighborhood Council budget allocations, resulting in less than a 1% savings to the overall budget, but a net real-dollar reduction of 48% compared to our 2007 allocations (\$50,000 which has the same buying power as \$61,866 today), I understand that BONC is not taking up that particular issue.

However, I would ask that you consider in any change to the allocation formula the extent to which a particular Neighborhood Council has City-owned property within its boundaries that can be used as meeting space, office space, or storage space, and therefore how much that NC must pay in rental of such spaces where the City does not have property. In our case, we have only \*one\* City-owned meeting room, in our local library, which is adequate for committee meetings but closes no later than 8 p.m., rendering it infeasible for much of our business. We are reliant on local restaurants, churches, and other businesses to provide meeting space for our general meetings and most of our committee meetings. We also have to rent a storage space for our outreach materials and event equipment, and we are unable to procure our own printing and computing equipment for lack of an office to set it up in; this results in additional costs incurred for printing materials.

Given that some NCs are more apt to expend their full budget than others, I would also recommend the following:

1) \*Ban\* the practice of sweeping unexpended funds into the City's General Fund.

2) Create an NC grants fund, where unexpended, un-rolled-over funds are swept.

3) Allow NCs to apply to this fund for additional funding, in the event they have exhausted their annual budget.

#### Regarding re-allocation of funds for NCs

Hello!

I heard about tonight's BONC special meeting, and don't know if I can attend. But I thought I'd take a chance and submit my personal view.

First, I agree that allocating by population makes sense. In Palms, we get less attention due to the transient nature of much of our stakeholders. This means it's much harder to do outreach; I assume that's true for other NCs with larger populations. To me, this is the most crucial function of the NCs: get stakeholders involved in L.A. policy, and outreach is our main job.

Second, I would support giving more funds to those areas who historically have not had enough of a voice. Especially now, given the spectrum of experiences we have as relates to policing, public safety, and other important government issues.

Third, I believe that DONE needs to be held accountable to do more work regarding outreach. My experience so far is that DONE outreach is a team of followers, not leaders. Given that our elected terms are 2 years in some NCs, and often not longer than 4 years, I think it behooves DONE to do more city-wide awareness work, and to provide more support for incoming board members who can take up to a year to come up to speed and then get anything accomplished. However, they need the staff, resources, and support to do this. I would support plans that allowed DONE to have white label tools that allow NCs to simply plug in and leverage for outreach and events. And I think DONE should, instead of informal "Hey, what have you done that works?" sessions, instead initiate packages that would make it easier for NCs to budget and execute events. Imagine if an NC could ask their DONE rep how to host a community day, and the rep could say "Here's everything you need, fill out the numbers and then we can review it to make sure it will sail through permitting and approvals." That's what I'd like to see, and I could see reducing NC budgets in exchange for some of that kind of service.

Finally, I have seen that we are getting more meaningful participation through Zoom. While I have concern about that specific platform, I think if DONE can provide the tools that having online meetings be more standard would make it easier for us to get people involved. I don't think it should be a complete replacement, but having it as an option in future I think would make for a better overall result for NCs.
