General Manager Comments:

General Manager gives update on FY 2021-22 Proposed Budget. The Department has been requested to submit an additional 10% reduction from the Revised Proposed Budget that was submitted to the Mayor's office. General Manager explains the City budget process. General Manager gives updates about administrative changes such as re-examination by the leadership team on NEA assignments and reorganization, as well as the implementation of furloughs. General Manager gave short update related to implementing Council Member Bonin & Koretz's motion for requiring a mandatory training for the Neighborhood Councils on Diversity Equity Anti- Bias & Inclusion. A total of 7 Planning 101 trainings have been held since October, and we are still in the process of getting information on the website. We are also still collecting information from Neighborhood Councils of who their committees are. The Department does not anticipate adding any additional trainings; they hope to possibly upload the Planning 101 training on Cornerstone to be available on an ongoing basis. On Grievance updates, Staff member Lorenzo Briceno will be dedicating his time on administrating the grievance process and procedures.

City Clerk Representatives' Comments:

Cheryl Hass provided update status on financial activities of Neighborhood Councils to date. Cheryl mentioned that their staff has processed and reviewed total check payment requests of 1,056. They approved 81% and denied 15% as they needed further clarification on what the purpose of the request was for. Their staff processes the requests at approximately 1.9 days each request, as average precedent time it takes to handle the requests. Their staff has reviewed 1,419 credit card receipts. They have flag credit card transactions of 47, and the report is better than last report. They have done virtual trainings include program policies and funding portals or topics in support to what Neighborhood Councils need. Currently 6 NCs are on E.E. combined.
