Department of Neighborhood Empowerment (D.O.N.E.) comments: Raquel Beltrán, General Manager reported The City continues to negotiate with labor organizations and the agreements reached will be presented to City Council. Currently, we do not expect furloughs between now and June 2021. However, we do expect to have unpaid days between now and June 2021 and deferred salary increases. A Data Literacy workshop was held last week with one hundred and three (103) participants in attendance representing seventy (70) neighborhood councils. We think we recruited one hundred (100) potential Data Liaisons who will go back to their neighborhood councils and request approval to be appointed as the Data Liaison for their neighborhood council. The evaluations after the session gave us tremendous insight as to how we might want to build the series moving forward. Our focus right now is to continue to seek and share accurate information and encourage everyone to stay safe. The Department will continue sharing vaccination information (VaxFacts) from the Mayor's website lamayor.org and the corona-virus.la website. The information provided on the corona-virus.la website can be translated into numerous languages. The Department is working on translating the Planning 101training and making it available on Cornerstone. The Department met with the Vice President of Government Affairs at Zoom Corporation. He was impressed with all of the work and dedication of the neighborhood councils. We shared that since the implementation of the Empower Virtual Governance Plan neighborhood councils have conducted three thousand three hundred (3300) webinars between May 2020 through December 2020. In response to the question of whether neighborhood councils are subject to the Brown Act. Yes neighborhood councils are subject to the Brown Act. There are three (3) characteristics that require this: 1st)The City Charter, 2nd) The Plan and the corresponding ordinances that implement the plan, 3rd) By virtue of neighborhood councils being certified by the City Council. This combination makes neighborhood councils legislative bodies of the City of Los Angeles, and subject to the Brown Act. Progress is being made as it relates to the entire grievance process. The department is waiting for neighborhood councils to provide the names of their regional panel recommendations from each of the neighborhood councils with a deadline of next week. The Department will decide who will serve on a regional panel after reviewing the recommendations. It is our view that the first responsibility in the certification of a grievance is to determine if it meets the threshold as described in the ordinance in order to proceed to the next.
