8. [1:40 PM] Mayor's legislative representative's updates on <u>pending legislation</u> regarding the Brown Act amendments.

City Representative: Brad Fingard, State of Intergovernmental and Legislative Affairs, provided updates regarding the Brown Act amendments. Some comments were that there are three bills remaining related to the Brown Act: 1) AB 2647 (Levine) described as minor and technical, which the City has not taken a position on. 2) SB 1100 (Cortese) of which City has not taken a position, and 3) AB 2449 (Rubio) related to teleconferencing, which the City

has not taken a position on. They are in the last two and a half weeks in this legislation session, last day being August 25<sup>th</sup>, and the 31<sup>st</sup> for each House to pass the bill and January 1<sup>st</sup> 2023 unless an emergency clause. He noted that in the next couple weeks the Mayor's office and Council President will send out solicitations to department general managers requesting legislative proposals to be taken up, and they will review those in September and October; narrow down priorities and get support through Council. If any go into effect next year, for purposes of this Commission and NCs, and Brown Act bodies he knows, he knows there is a desire for further teleconferencing flexibility, which is something they are requesting from the Department and Commission here. Mr. Fingard clarified what the City not taking a position signifies is that there have been no resolutions to introduce any of these three bills to the City's legislative program, which he believes it is unlikely to happen within the short time left.

Public Comment: Josh Nadel, Jennifer Goodie, Glenn Bailey, Goat Puppet n., Jamie York, Garry Fordyce.

Commission Comment: Commissioner Shaffer, Commissioner Lipmen, and Commission President Regalado who thanked Mr. Fingard, thanked GM Beltran for her suggestions, and recommended this be placed on the next agenda-setting meeting agenda.

D.O.N.E. Representative, General Manager Raquel Beltran expressed her appreciation for Brad Fingard having organized this presentation. Her requests are to form an ad hoc committee dedicated to this topic, and from Mr. Fingard, when information is sent to the CAO's office related to this topic, she would like us to get that information as well, requesting assistance for the department to be able to advocate for the NCs, and asked him to refer to the EmpowerLA Readiness Survey that they just concluded.

# 9.[2:12 PM] Introduction of the new Olivia E. Mitchell Youth Council members.

D.O.N.E. Representative, General Manager Raquel Beltran noted that she was accompanied by Vanessa Serrano, Director of Civic Leadership in the Department & Erika Gatica, NEA, who provided leadership on this. General Manager Beltran gave background on the Olivia E. Mitchell Youth Council; their goal and purpose is to identify solutions to improve programs, policies and practices affecting young people in the City of Los Angeles. They will partner with community organizations, civic leaders and youth leaders to develop new strategies and approaches to serving youth in the City of Los Angeles. They will be making recommendations to members of the City Council and the Mayor on issues such as City budgets, programs and policies related to youth development. Ms. Beltran noted that they were sworn in before City Council on August 5th and a ceremony was held.

She noted four NC youth members were also appointed, two of whom had joined us today: 1) Miriam Torres Sanchez, a 20-y-o board member on the Historic Highland Park NC, Chair of the Youth and Education Committee, and 2) Furkan Yalcin, President of the North Westwood NC. Ms. Beltran noted that the other two OEM Youth Council members are Charlie Saff a 17-y-o high school student on Rampart Village NC since 2021, and Zaid Diaz-Arias, a 20-y-o on the North Hollywood Northeast NC for four years, advocating for a youth council.

Olivia E. Mitchell Youth Council members who introduced themselves: Furkan Yalcin and Miriam Torres Sanchez.

GM Beltran and Commission President Regalado gave their appreciation for Miriam and Furkan.

Public Comment: Jennifer Goodie, Garry Fordyce, Cindy Cleghorn, Jamie York, Anna Measles and Josh Nadel.

D.O.N.E. Representative: General Manager Raquel Beltran, noted that she was accompanied by members of the department's tech team, Gibson Nyambura, Freddy Cupen-Ames, Jose Galdamez and Kyle Stone, who have worked on this...

Freddy Cupen-Ames provided an overview of the survey, in the form of a story-map presentation as to the EVG workgroup's NC returning to in-person readiness survey. Some points included data was collated, and responses were broken down by region, by demographics as well as by barriers to meeting in person, and that that this survey was translated into 10 languages for the 99 NCs. Ms. Beltran provided further information, including a range of statistics on those who submitted comments. At the conclusion of the presentation on the findings of the survey, GM Beltran expressed her appreciation for those who worked on this, noting that they are offering additional resources through the link under 12.a. She thanked those who contributed to this.

EVG Workgroup Representative: Josh Nadel. Josh gave update including strategies to increase membership and noting that they'll be deciding on which NCs to be part of the pilot program as well as next steps.

He noted that the LAPD's report back two days after the incident was that what occurred in San Pedro is not a "Harbor Community story," it is a "larger LA story." If the underlying item for reconsideration has not been placed on the agenda for that next regular meeting, then it shall be considered at a subsequent meeting pursuant to the Ralph M. Brown Act.
